## GENERAL RULES

---

- Both owners and riders must be NRCHA & MVRCHA members.
- A copy of your horse's registration papers must accompany your entry form.
- All NRCHA Rules Apply. Sign waiver below prior to competing.
- \*\*Junior Horse Class—Open to Non Pros who have not won more than \$3500. Horses 3-5 years of age may be ridden in a snaffle bit or hackamore. NRCHA bit and hackamore rules apply.
- \*\*\*Bridle Pro/Am—Open to both Non Pro and Open riders who have not won more than \$1500. NRCHA bit rules apply.
- \*Provisional classes—not eligible for awards
- \*<sup>1</sup> NPL Class-Provisional for 2008 & 2009
  - 1. Open to Non Pro Riders who have not won more than \$5000 in down the fence classes.
  - 2. Must own your own horse.
  - 3. Class will not count for MVRCHA standings, Intermountain Circuit Standings, Regional Standings, World Show Qualification, or National Standings.

### ASSUMPTION OF RISK AND WAIVER OF LIABILITY AND RELEASE

I, the undersigned, wishing to personally participate (or to have my minor child) participate in this equine event produced by the MVRCHA and in further consideration of the mutual covenants given by other participants, voluntarily give this Assumption of Risk and Waiver of Liability and Release. I understand that being around horses and cattle carries certain inherent dangers-both known and unforeseeable-and that in order for myself (and/or my minor child) to participate in this event, I must expose the participant to the dangers of actions and events precipitated by horses, people and cattle. I understand that sometimes there is reasonable action or inaction to be undertaken to avoid those risks of injury to persons or animals. Therefore, I willingly assume those risks of injury to myself (or my minor child) and to my property. I waive, release, and in advance, forgo my right to pursue any such claims, causes of action or right to pursue civil damages against the MVRCHA, its agents, volunteers, members, employees, and/or cattle contractors whether for personal injury or for property damage including those alleged to have arisen out of negligent and/or grossly negligent act or omission. Further, I agree to indemnify and to hold harmless the MVRCHA, its agents, volunteers, members, and/or employees from any cost arising out of injury to myself (or my minor child), or to my property.
